RESOLUTION NO. 15 -2024

**A CORRECTIVE RESOLUTION BY THE CHEROKEE COUNTY, KANSAS BOARD OF COMMISSIONERS
REGARDING PRIOR PROCLAMATION OF A STATE OF LOCAL DISASTER EMERGENCY**

WHEREAS A state of local disaster emergency may be declared by the chairperson of the board of county commissioners of any county, or by the mayor or other principal executive officer of each city of this state having a disaster emergency plan, upon a finding by such officer that a disaster has occurred or the threat thereof is imminent within such county or city. No state of local disaster emergency shall be continued for a period in excess of seven days or renewed, except with the consent of the board of county commissioners of such county or the governing body of such city. K.S.A. 48-932(a).

WHEREAS on April 29, 2024 at the regularly scheduled meeting of the Cherokee County, Kansas Board of Commissioners, Cherokee County Road & Bridge Supervisor Cody Zook informed the Board, as of such date, Cherokee County had incurred approximately \$75,000 in damage due to heavy rain and severe thunderstorms beginning on April 25, 2024.

WHEREAS on April 29, 2024 at the regularly scheduled meeting of the Cherokee County, Kansas Board of Commissioners, Chairman Cory Moates, based on the information provided by Zook, made a motion to declare a State of Local Disaster Emergency. Commissioner Lorie Johnson seconded the motion. The motion passed unanimously.

WHEREAS at the next regularly scheduled meeting of the Board on May 6, 2024, a formal resolution was adopted unanimously by the Board, Proclaiming a state of local disaster emergency.

WHEREAS such conditions have created obstructions which endanger health, safety, and welfare of persons and property within the border of Cherokee County, Kansas.

NOW THEREFORE be it resolved by the Board of Commissioners of Cherokee County, Kansas:

That the Board of County Commissioners of Cherokee County, Kansas, under and by virtue of the authority vested in it by K.S.A. 1976 Supp. 48-932, does hereby PROCLAIM a State of Local Disaster Emergency.

IT IS FURTHER RESOLVED AND PROCLAIMED that the area within the border of Cherokee County, Kansas covered by this proclamation/resolution is the entire area of Cherokee County, Kansas.


BE IT FURTHER RESOLVED that said Board has all rights and/or powers to perform such functions as are vested in said Board by and through the provisions of the Kansas Emergency Preparedness Act of 1975.

IT IS FURTHER RESOLVED AND PROCLAIMED that this resolution shall remain in effect for a period of fourteen (14) days from the date the original emergency proclamation resolution was adopted, unless terminated earlier or renewed by consent of the governing body.


BE IT RESOLVED this 20th day of May 2024 by the Cherokee County Board of Commissioners.


