MINUTES FOR APRIL 29th, 2013

BOARD OF CHEROKEE COUNTY COMMISSIONERS

CHEROKEE COUNTY, KANSAS

CONVENE

Chairman Richard Hilderbrand called the regular session of the Cherokee County Board of Commissioners to order and led all in attendance in the Pledge of Allegiance at 9:00 AM on Monday, April 29th, 2013 in the Commission Room, #109 of the Cherokee County Courthouse. Commissioners Pat Collins, Charles Napier, Richard Hilderbrand, and County Clerk Rodney Edmondson were present.

Members of the press present: Larry Hiatt, Patrick Richardson, and Machelle Smith

A motion was made by Commissioner Hilderbrand for an Executive Session for the purpose of Non/Elected personnel for a period of 5 minutes, attended by the Commissioners only. It was second by Commissioner Collins. The motion carried 3-0 with all voting yes at 9:11AM.

The meeting reconvened at 9:17AM.

Leonard Vanatta - County Road Supervisor Gene Langerot - County Lot Supervisor

They appeared before the Board on routine county business. No action was taken.

Ron Costlow, Doug Mogle, Mike King - Cherokee County Ambulance

They appeared before the Board representing Ambulance Districts #1 - #3. They provided a general update concerning the future funding for ambulance purchases. District #2 has two new trucks, things are going well. District #3 will have their new truck in a couple of months. Galena lost another 2006 model to an engine failure. It's just sitting now. Columbus and Galena each need to get one more truck replaced. The cost for each unit is estimated at \$75,000 - \$80,000 to replace the chassis and remount the box that is currently being used. They need to replace two that way. They have secured a line of credit to get at least one unit remounted. Then, District #3 will need another one in a year or two. Commissioner Collins has met with all districts and they are working on a long term plan. It's possible that they can purchase a new unit every two years. That would include remounting the box onto a new chassis at least once. They will spend the next twelve months working out the details. They are currently working on a plan through 2021 and will report back to the Board at a later date.

Machelle Smith - Tourism & Economic Development

She appeared before the Board regarding the Sentinel Times' plan to publish a new magazine to promote tourism in Cherokee County. They will have a website with a complete directory of businesses and organizations. They will promote everyone, not just one city or area. There are three big festivals coming to Cherokee County and Cherokee County needs to be promoted, so the visitors stay and visit other areas of Cherokee County while they are here.

Steve Goehl - D.A. Davidson & Co.

He appeared before the Board as a follow up to the possibility of refinancing the jail bonds. He has done further research and wanted to bring them up to date. His initial recommendation still holds, don't refinance right now.

Commissioner Hilderbrand made a motion to amend the agenda for Susan Galemore with SEK Regional Planning Commission from 10:30AM to 10:24AM. It was second by Commissioner Collins. The motion carried 3-0 with all voting yes.

Susan Galemore - SEK Regional Planning Commission

She appeared before the Board to update them on the NSP property located at 402 East 5th street in Galena. It was a foreclosed property that the grant purchased for resale. It has been on the market since November 2011, without a single offer to purchase. The grant money is running low that would provide for utility costs, mowing, etc. When that runs out, the county will have to pick up the costs. She recommended that the Board amend the agreement to allow the grant to pay 100% of the closing costs. She also asked the Board to consider lowering the price again. Currently it's listed at \$50,000 with an appraised value of \$60,000. She presented a new Authorized Signature Form as well as a new Action Plan for signatures.

A motion was made by Commissioner Hilderbrand to sign the Neighborhood Stabilization Program Action Plan to pay 100% of the closing costs, and to lower the selling price of the property to \$40,000. It was second by Commissioner Collins. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Collins to approve the Minutes of the April 22nd, 2013 County Commissioners' Meeting as written. It was second by Commissioner Napier. The motion carried 3-0 with all voting yes.

Joni Henry - Columbus Saddle Club

She appeared before the Board seeking sponsorship from the Commissioners for the upcoming year. The Board took it under advisement.

A motion was made by Commissioner Hilderbrand to amend agenda for Mac Young and the Community Corrections Program from 11:00 AM to 10:51 AM. It was second by Commissioner Collins. The motion carried 3-0 with all voting yes.

Mac Young - Community Corrections, 2014 Plan

He appeared before the Board to get approval for the Community Corrections Comprehensive Program for 2014. He presented the application form for their signatures.

A motion was made by Commissioner Collins to approve and sign the Community Corrections Comprehensive Program Grant Application for the year 2014. It was second by Commissioner Napier. The motion carried 3-0 with all voting yes.

Commissioner Collins made a motion to adjourn until the next regularly scheduled meeting set for May 6th, 2013. It was second by Commissioner Napier. The motion carried 3-0 at 11:27AM.
