MINUTES FOR AUGUST 25, 2014

BOARD OF CHEROKEE COUNTY COMMISSIONERS

CHEROKEE COUNTY, KANSAS

CONVENE

Commissioner Hilderbrand called the regular session of the Cherokee County Board of Commissioners (The Board), to order and led all in attendance in the Pledge of Allegiance at 9:00 AM on Monday, August 25, 2014 in the Commission Room, #109 of the Cherokee County Courthouse located at 110 W Maple St., Columbus, Kansas. Commissioners Richard Hilderbrand, Charles Napier, Pat Collins, and County Clerk Rodney Edmondson were present.

Members of the press present: Larry Hiatt, Machelle Smith, and Thom Hanrahan

A motion was made by Commissioner Collins to approve the Minutes of the August 18, 2014 BOCC Meeting as written. The motion was seconded by Commissioner Napier. The motion carried 3-0.

A motion was made by Commissioner Collins to purchase a new plotter as requested by Rebecca Brassart for the 911 Addressing & Mapping Department at a cost of \$7,130. The motion was seconded by Commissioner Napier. The motion carried 3-0.

County Clerk Edmondson informed the Board that Gene Mense will be here on Monday, September 8th at 1:00 PM for a Budget Workshop. A copy of all of the proposed budgets that have been turned in to the clerk, has been sent to him. Commissioner Hilderbrand asked each commissioner to have a proposed budget ready for consideration on that day.

County Clerk Edmondson informed the Board that there have been 23 Applications For Real Property Tax Relief that have been received from residents of Baxter Springs for damages resulting from the tornado on April 27, 2014. A hearing date needs to be set for the Board to consider the applications. He stated that County Appraiser Kim Lauffer suggested a hearing date of September 22, 2014. The Board agreed to set the hearings on September 22, 2014 at 1:00 PM, and instructed Clerk Edmondson to notify all applicants of the date and time of the hearing.

Leonard Vanatta - County Road Supervisor Gene Langerot - County Lot Supervisor

They appeared before the Board on routine county road business.

Tonya Hodge appeared before the Board concerning the adoption of Bison Road as a county road.

Rebecca Brassart from 911 Mapping & Addressing stated that the road currently has easements of 20 feet. There are five property owners with easements.

Leonard stated that the condition of the road needs to be improved with ditches and culverts installed. He said that 40 foot easements will need to be obtained from all property owners and then bring the road up to standards. He will get with Hodge after he reviews the road again.



Terry Clugston - Undersheriff

He presented a request to replace three computers used by 911 Dispatch. They are five years old and one is currently down. They are used 24/7. Total cost to replace all three is \$2,529.52, including a four year warranty.

A motion was made by Commissioner Collins to purchase three computers for the 911 Dispatch from 911 Funds. The motion was seconded by Commissioner Napier. The motion carried 3-0.

A motion was made by Commissioner Napier to approve the e-Dispatches.com contract renewal at a cost of \$378 from 911 Funds. The motion was seconded by Commissioner Collins. The motion carried 3-0.

A motion was made by Commissioner Collins to enter an Executive Session with the Board, Leonard Vanatta, Tammie Speer, and Gene Langerot for the purpose of Non/Elected Personnel for a period of 20 minutes. The motion was seconded by Commissioner Hilderbrand. The motion carried 3-0 at 9:37 AM.

The meeting reconvened at 9:57 AM.

No action taken as a result of the Executive Session.

Gretchen Andrews, Kelly Fincher - Class LTD

They appeared before the Board seeking permission to use county roads for a 5K run sponsored by Class LTD. The event will take place on October 4, 2014 beginning with registration at 7:00 AM and should conclude by 10:00 AM. The City of Columbus has approved the route in town, but they need the Boards approval to use Wyandotte Road out in the county. The Board gave their approval.

A motion was made by Commissioner Hilderbrand to amend the agenda from 10:15 AM to 10:06 AM for the Methodist Church. The motion was seconded by Commissioner Collins. The motion carried 3-0.

Francine Boulware - Methodist Church Office

She appeared before the Board concerning the Thrift Shop and Office on Pine Street. They are requesting a special tax sale for the condemned property next to their office that is to be torn down. The City of Columbus is holding some of the church's insurance money and it is being used to tear down both buildings and they are wanting to purchase the other property to expand their office when they rebuild. They believe no taxes have been paid since 2006 and approximately \$8,800 is owed in back taxes. The Board will consult with Mr. Coleman about a special tax sale and report back to the Church.

Carl Hayes - Health Department

He appeared before the Board with a worksheet for the Five-Year Solid Waste Management Plan. The Board will review and discuss the plan at their next meeting.

A motion was made by Commissioner Hilderbrand to approve the District Court Budget for 2015, requesting County Funds in the amount of \$37,000. The motion was seconded by Commissioner Napier. The motion carried 3-0.

A motion was made by Commissioner Hilderbrand to amend the agenda from 11:00 AM to 10:55 AM for Melinda Mayfield. The motion was seconded by Commissioner Napier. The motion carried 3-0.

Melinda Mayfield - All God's Creatures



She appeared before the Board seeking financial assistance with their animal rescue program.

She reported that 257 animals have been adopted this year. They have several projects that she would like to see completed. The Board took her request under advisement.

Scott Jackson & Karrah Smith - Spring River Mental Health Truancy Program

They appeared before the Board to bring an update regarding the Truancy Program. Additional funds of \$10,000 were secured from the Juvenile Justice Authority and the five school districts are providing the remainder of needed funding. No County Funds are being requested for 2015.

Nathan Coleman - County Counselor/Attorney

He appeared before the Board on legal matters concerning Cherokee County.

Carl Hayes appeared before the Board requesting an appointment to the Air Alliance Group as Cherokee County's representative. Mr. Coleman will draft a resolution for consideration on September 8th and Carl will provide more information about the group.

Mr. Coleman stated that procedural defects caused the Grand Jury Petition to be denied by the Court. He stated that the county should consider a reserve fund of \$30,000 - \$50,000 to cover the costs of a potential Grand Jury in the future.

The Board discussed the Methodist Church Thrift Shop with Mr. Coleman, and he will look into the possibility of a special tax sale for just one property.

Mr. Coleman presented the 2015 Budget Request for the County Attorney's Office for the Board to consider.

Commissioner Hilderbrand made a motion to adjourn until the next regularly scheduled meeting set for September 8, 2014 at 9:00 AM. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes at 12:24 PM.

The Board will not meet the week of September 1, 2014 in observance of the Labor Day Holiday.

Cherokee County Truancy Program

First and foremost, we would like to thank the Cherokee County School Districts and County Commissioners for the funding that has been provided to the Cherokee County Truancy Program. Without your support, this valuable program would not have been available in 2014.

As discussed last year, funding for the program has been cut through the years. However, we have been informed that we will be given an additional \$10,000 in JJA Prevention monies to apply towards funding the truancy tracking portion of this program for SFY15. We will also receive \$5,556 that will provide for the truancy counseling sessions for families. The following chart provides data for the past five years. As you will see there was an increase in the number of new youth being referred by the school districts during this past year.

As of July 1, 2013, with the support that the school districts and the commissioners provided, SRMHW has been able to maintain the position of Truancy Tracking Officer for our county schools. The funding provided in SFY 14 by each school district / county commissioners was \$4,400 for a total cost of \$22,000 for this program. However, this year with the additional \$10,000 given through JJA; the cost to the five schools (USD # 247, 404, 493, 499, and 508) would be \$2,400 for a total cost of \$12,000. This includes personnel costs to complete duties such as gathering and tracking school attendance and grades, completion of truancy intakes, preparation of court reports, routine court appearances, direct contact with youth and parents, maintaining contact with school personnel, providing truancy counselors with necessary information and travel expenses. At the present time, we do not anticipate any increase of costs to administer this

program.

The CKCO Truancy program continues to produce positive outcomes and we believe it is a service that remains necessary in supporting the school and court system. During the last fiscal year ending June 30, 2014, 86% of youth discharged successfully completed program requirements and improved their school attendance rate.

We believe this program continues to be vital for families, school, and the court system. We are asking for your continued support in order for the program to be provided into SFY 2015. Unless funding is secured, we will no longer be able to provide the tracking and monitoring of truancy cases as of September 1, 2014.
