MINUTES FOR AUGUST 10, 2015

BOARD OF CHEROKEE COUNTY COMMISSIONERS

CONVENE

Commissioner Hilderbrand called the regular session of the Cherokee County Board of Commissioners (The Board), to order at 9:00 AM on Monday, August 10, 2015 in the Commission Room, #109 of the Cherokee County Courthouse located at 110 W Maple St., Columbus, Kansas. Commissioners Richard Hilderbrand, Charles Napier, Pat Collins, and County Clerk Rodney Edmondson were present.

Jess Hunt of Baxter Springs led all in attendance in the Pledge of Allegiance. Mr. Hunt appeared at the invitation of the Board in honor of his 100th birthday tomorrow, August 11, 2015.

A motion was made by Commissioner Collins to approve a Proclamation honoring Jess Hunt on his 100th birthday. The motion was seconded by Commissioner Hilderbrand. The motion carried 3-0.

Commissioner Collins presented the framed Proclamation to Mr. Hunt, congratulating him on his achievement, and thanking him for his service in WWII.

County Clerk Edmondson, Mr. Hunt's grandson, presented an American flag purchased by the family to Mr. Hunt. The flag will be flown over the Courthouse on Tuesday in honor of his 100th birthday.

A motion was made by Commissioner Collins to approve the Minutes of the BOCC Meeting for August 3, 2015. The motion was seconded by Commissioner Napier. The motion carried 3-0.

A motion was made by Commissioner Collins to approve the Mid-Month Accounts Payables for August, 2015. The motion was seconded by Commissioner Napier. The motion carried 3-0.

Commissioner Hilderbrand stated that he had talked with Gene Mense regarding the 2016 Budget. He stated that the county was looking strong and if the budget remains the same as last year, the mill levy will likely stay the same or possibly decrease just a little.

Commissioner Hilderbrand read a letter from Dennis Degner of KDHE, addressed to Galena Mayor Dale Oglesby regarding the City of Galena's Application for a Solid Waste Landfill Permit. A copy of the letter is attached.

Commissioner Hilderbrand informed everyone that he has tendered his resignation to the Governor effective September 1, 2015. He stated that he plans to move outside his district making it impossible for him to serve.

Leonard Vanatta - County Road Supervisor

He appeared before the Board concerning county road business.



Gabe Cordova - ECCHIC Employee Benefits

He represents Employers Committed to Controlling Health Insurance Costs, and appeared before the Board regarding health insurance benefits for county employees. They use a Third Party Administrator with direct contracts for some services. He asked the Board for approval to submit a proposal at the time of renewal. The Board instructed him to get with Deana.

Nathan Coleman - County Counselor

He appeared before the Board regarding legal matters concerning Cherokee County.

A motion was made by Commissioner Hilderbrand to enter an Executive Session with the Board and Mr. Coleman for the purposes of Attorney/Client Privilege and Non/Elected Personnel for a period of 25 minutes. The motion was seconded by Commissioner Collins. The motion carried 3-0 at 11:37 AM.

A motion was made by Commissioner Hilderbrand to enter an Executive Session with the Board, Mr. Coleman, Noxious Weed Director Kristin Seal, and Counsel Robert Myers for a period of 10 minutes for the purpose of Non/Elected Personnel. The motion was seconded by Commissioner Napier. The motion carried 3-0 at 12:08 PM.

The meeting reconvened at 12:18 PM.

No action was taken during the Executive Session.

A motion was made by Commissioner Hilderbrand to enter an Executive Session with the Board and Mr. Coleman for the purpose of Non/Elected Personnel for a period of 10 minutes. The motion was seconded by Commissioner Napier. The motion carried 3-0 at 12:19 PM.

The meeting reconvened at 12:25 PM.

No action was taken during the Executive Session.

A motion was made by Commissioner Hilderbrand to discharge Kristin Seal as Noxious Weeds Director. The motion was seconded by Commissioner Napier. The motion carried 3-0.

A motion was made by Commissioner Hilderbrand to appoint Cecil Brown as Noxious Weed Director for the remainder of 2015. The motion was seconded by Commissioner Napier. The motion carried 3-0.

Commissioner Hilderbrand made a motion to adjourn until the next regularly scheduled meeting set for August 17, 2015 at 9:00 AM. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes at 12:27 PM.

Dear Mr. Oglesby:

The Department received an application for the proposed Galena MSW facility on August 5, 2015. On this same day I talked with Mr. Doug Gatewood, agent for Jordan Disposal. In this discussion I explained that the Department is not authorized to review any application before specific approval is granted by local government. The Department's statutory reference K.S.A. 65-3407(m) states, "Before reviewing any application for a solid waste processing facility or solid waste disposal area, the secretary shall require the following information as part of the application", including consistency with the solid waste management plan, consistency with local zoning or compatibility with surrounding land use, and requirements of land ownership. This permit application did not have local government certification signatures.

The letter dated July 27, 2015 from Mr. Richard Hilderbrand, Chairman, Board of County Commissioners, Cherokee County, to you and copied to me states that these local government requirements have not been approved for this application process; therefore, the department is returning the complete application package to you.
