Voters from this location will now vote at Scammon Holiness Mission (East Building), 207 N Sixth Avenue, Scammon, KS 66773.** Polls will be opened and closed at the regular times of 7:00 am and 7:00 pm specified by law for the conduct of elections. Voters who previously voted at Galena City Hall will now vote at Galena Senior Center. Voters who previously voted at Center Christian Church will be split between Baxter Springs Community Building and Columbus Extension Office.
